- 1) District Budget FY 24-25 Presentation (I)
- 2) Financial Reports: Balance Sheet FYTD 2024, Income Statement FYTD 2024, Draft FY 24-25 Budget, Covid19 Fund Balance, COVID19 Expense Breakdown, FY 2023-2024 Budget to Actual (I) SRCD Financial Controller, Sokmarly In (Marly), went over her starting process of organizing the District's finances.
